

WHO WE ARE

Founded in 1974, the Wisconsin Council of Religious & Independent Schools (WCRIS) is a nonprofit, nonpartisan government relations organization representing 100,000 K-12 students in 600 Catholic, Lutheran, Christian, Seventh Day Adventist and independent schools across the state.

WCRIS is a member of the Council for American Private Education (CAPE), our national affiliate that monitors federal legislation and advocates on our behalf in Washington, D.C.

WHAT WE DO

- Seek equitable access to educational opportunities;
- Ensure that public policies advance fairness and justice;
- Defend the right of parents to select the best education for their children;
- Defend the right of schools to pursue their unique missions;
- Facilitate communication and collaboration among our schools, their leaders and the communities we serve.

OUR ACCOMPLISHMENTS

- Helping amend the state constitution to provide equitable busing for private school children;
- Gaining inclusion for private schools in the federal E-rate and state TEACH educational technology programs;
- Advocating for the Milwaukee Parental Choice Program to include religious schools and to expand statewide;
- Protecting private school students' access to federal special education services;
- Providing professional development and support for private school administrators;
- Helping create a Wisconsin tax deduction for K-12 tuition expenses, saving private school parents an estimated \$30 million annually.

SOME HISTORY

- Early Wisconsin education was primarily private or religious. It brought mass schooling and literacy to the state well before the public school system was created.
- WCRIS was founded as the Wisconsin Association of Nonpublic Schools in 1974 by a group of Catholic, Independent Christian and Lutheran school leaders who had first organized in the 1960s to advocate for equitable busing for private school students.
