I am the Music Teacher at St. Joseph's Catholic School in Menomonie, WI. We are a Pre-K - 6th grade Catholic school that welcomes students of all faiths. We offer a "fair share" tuition option that allows students of any economic background to attend regardless of ability to pay tuition. Our school serves around 140 students from Menomonie and the surrounding rural areas, and we emphasize character development and personal responsibility from a Christian perspective at all age levels.

The focus of this grant application is our annual Christmas program. Each year, the sixth grade students rehearse before and after school for two hours a week, from early October to mid-December. They memorize their lines, design and learn blocking, are fit for costumes and find and organize their own props. The script, which is written specifically for each year's class, gives each student an opportunity to perform on stage in a way that will guarantee success. The rest of the school works to learn music that will complement the story. Each of the 140 students has an important piece of the complete production. These productions are not only a great learning experience for the students, but draw a large audience. It is a unique opportunity that students remember long after graduating from St. Joseph's School. The program is financially self-sufficient and relies on many parent, teacher, and student volunteer hours.

We would like to purchase wireless microphones for our student actors so that all audience members can hear the final product of so many hours of hard work each year. Currently, only one of our students can be miked at a time, and the students are limited in designing the blocking because we have to work around wired microphones that are passed from person to person. The purchases from this grant will allow us to give every student a microphone with much less switching back and forth, and will also allow the students to learn about sound production and act as sound technicians during rehearsals and performances.
